OBJECTIVES OF TRAINING

The training in the master's program "Business Innovation and Management / in English / (joint program)" lasts 2 semesters and aims to prepare highly qualified managers at middle and high management level for business needs. - Acquisition of knowledge and skills that stimulate effective strategic management, smart decision-making and business innovation;
- Acquiring the necessary skills to deal with problems in business by increasing knowledge of crisis management;
- Acquiring skills for identifying business opportunities and introducing new business ideas through the possession of strategic skills and interdisciplinary knowledge.

The general theoretical and specialized content of the training in the master's program "Business Innovation and Management / in English / (joint program)" is consistent with all new theoretical knowledge and new trends in corporate security and successful business:

- Teaching current disciplines related to the subject and subject of the specialty "Business Innovation and Management / in English / (joint program)";
- Teaching through the use of interactive whiteboards, video cameras and computers of the latest generation;
- Use of digital laboratories in the practical training of students;
- Periodic updating of the curricula in the disciplines of the curriculum;
- Forming a team of teachers, incl. specialists from the Department of National and Regional Security, the Department of Management and experts from the Dimitar A. Tsenov Academy of Economics, in order to guarantee to the greatest extent, the quality of the educational process;

The training course ends with the development of a master's thesis, the topic of which is tailored to the individual interests of students, given their future or current professional realization.
